Re: Florida CRC Proposal 95

Dear Commissioners Donalds and Nocco,

I'm writing in opposition to Proposal 95 which would effectively destroy the home rule powers the Florida voters approved fifty years ago and have relied upon since. My opposition to Proposal 95 is three-fold:

- 1) The language is confusing and ambiguous. If I am having a difficult time fully understanding it, I believe many Florida voters would also share that difficulty.
- 2) To the extent I understand it, Proposal 95 would unfairly favor large commercial enterprises at the expense of local businesses.
- 3) Proposal 95 would effectively change government closest to the People (Home Rule) into government closest to state Capitol favoritism.

Please do not approve or forward Proposal 95.
