Similarly we need to remind ourselves, our legislators and our citizens that in Florida's counties, Florida lives here - as do the opportunities and solutions for a better Florida. They reside with each of us and our individual counties and regions - not in Tallahassee.

Last year, FAC was successful in electing Bryan Desloge as 2nd Vice President of the National Association of Counties. In addition, we made multiple trips to Washington D.C.to advocate for solutions to address challenges facing Florida.

Over the next year, we have many issues before us: healthcare, finances, taxes, growth management, the environment and the economy. However if Florida is to triumph over these adversities, it will require local solutions that will differ across regions.



WHAT HAPPENED

- Increased the Florida Local Government Finance Program (FLGFP) portfolio by 25% and added first new client in over five years to the program. The FLGFP Board voted to appropriate \$50,000 for FAC to use in marketing the program, an unprecedented action.
- Accomplished a comprehensive maintenance project on the building, to include exterior and interior painting, floor refinishing and outside lighting.
- Prepared a new IT Strategic plan focusing on upgrading our membership database platform as well as creating a mobile office platform.
- Successful financial audits of FAC, the Florida Counties Foundation (FCF), Gulf Consortium and Florida Local Government Finance Commission (FLGFC). All received an ungualified opinion of financial statements managed by FAC.

Affiliate Management

FAC membership is by county. Therefore, FAC is expanding its focus on facilitating key county staff affiliate programs to provide increased member benefits to Florida's 67 counties. For the past decade, FAC has focused on growing the Florida County Attorneys Association (FACA) and in the past couple of years forming a County Managers Association.

• In 2014, FAC continued our expansion of affiliates by entering into a partnership agreement to provide administrative services to the Florida Association of County Engineers and Roadway Superintendents (FACERS). The agreement will allow us to support this valuable affiliate while furthering our connectivity to key members of county staff.

Vehicle Purchasing

Florida Local Government Finance Program



WHAT HAPPENED

FAC's longtime education partner UF/IFAS Extension celebrated their 100th Anniversary, a century of serving Florida in 2014. UF/IFAS Extension continues to be the sole sponsor of all of FAC's education certification programs-FACTOR. This continued partnership allows FAC to improve member benefits by continuing to grow our program offerings.



FACTOR Programs Continue to Grow

At Annual Conference, FAC graduated 42 Certified County Commissioners (CCC) for a total of 380 CCC alumni. In addition, 13 commissioners received their Advanced County Commissioner Certification (ACC) for a total of 145 ACC alumni. FAC also graduated our first class of Torchbearers at this event. A total of 26 ACC Alumni earned enough points throughout the year by participate in various programs or FAC Leadership roles to be eligible for this new designation. Congratulations to all of the commissioners that graduated from these prestigious programs!

Expanded Ethics Programs

For the last twenty years, FAC has offered a comprehensive mandatory Ethics, Public Records and Sunshine Law Course as part of FAC's Certified County Commissioner (CCC) Program. During the 2013 Legislative Session, the

Florida legislature passed ethics legislation requiring that County Commissioners and Constitutional Officers take four hours of Ethics programming each calendar year. In order to meet the needs of the membership, FAC began offering our existing program that addresses the issues in this legislation. Ethics programming is now held three times a year onsite in conjunction with FAC conferences. FAC also added an online course modeled on the same material that can be completed at our member's convenience and own pace.

Curriculum Review Committee

The Curriculum Review Committee held their biennial meeting in October to review the course offerings and curriculum for the FACTOR programs to prepare for the upcoming 2014-16 calendar of events. In addition to curriculum updates, the Committee discussed plans for implementing a County Staff Certification Program.

Update FACTOR Knowledge Centers

FAC currently has a library of reference materials on a variety of topics that affect local government. FAC plans to up the CCC program videos this year and add additional materials to make these centers more robust with con and information.

We will also hold the FAC Leadership Summit in conjunction with this event.

Centralized Events and Low Conference Fees

FAC will continue to hold events in central locations. In 2015, our major events will be in Leon, St. Johns, Pinellas and Nassau Counties. FAC is also holding several of the education certification programs in conjunction with our main conferences and have instituted one-day registration rates to encourage participation while saving limited travel dollars.

Increased Technology

FAC will be providing more streamlined technology this year that will improve conference registrations and the overall attendee experience. The updated web-based membership login will allow you to more easily participate at FAC events, keep track of what committees you serve on and track your education credits. In addition to this new program, FAC continues to strive to provide Wi-Fi access at each of our meetings and to utilize the FAC App during each event to download important conference materials.

WHAT HAPPENED

- Led group of 23 counties to file suit against the Department of Juvenile Justice, challenging a revised version of new administrative rules governing the amount of contribution owed from the non-fiscally constrained counties on their state mandated share of the pre-disposition secure detention costs.
- Produced FAC's first ever comprehensive and credible report on Unfunded Mandates imposed on counties by the State of Florida. Work product was the result of the first law clerk hired by the Association.
- Elevated FAC's national stature on issues related to county ethics and governance by being invited by NACo to the NACo Annual Conference to give an hour long presentation on Ethics in County Government.

WHAT WILL HAPPEN:

- Provide professional association services to the county engineers and county managers as FAC seeks to strengthen its relationship with certain key county staff groups;
- Expand FAC's county resource capability by directly providing detailed research and analysis on all state preemptions that exist on county home rule authority; and
- Assist the Gulf Consortium in its transition from a startup phase to an actual operating stage of services and planning.


State Legislative Successes

Every year, FAC advocates on behalf of our members to preserve and protect home rule - focusing on stopping legislation that would impose unfunded mandates or preempt county authority and supporting legislation that improves the services provided to Floridians.

Blocked Unfunded Mandates & Increased Funding

- Mitigated the cumulative negative impact of the comprehensive tax cut package on local revenues by reducing the projected negative impact of up to \$360M, to approximately \$10M, and in doing so, defeated efforts to reduce the sales tax on commercial leases and reduce the Communications Services Tax.
- Secured an exemption from the statutory requirement • to spend 1.5 percent more per year on county funded court system obligations court, saving counties close to \$7M.

- Included in the General Appropriations Act funding • in the amount of \$88.5M for water projects, \$30M for springs restoration, and \$4M for citrus disease research and breeding programs.

 - Prevented prohibitions on local governments from using red light cameras.

Better Programs

- Partnered with government and community • stakeholders to pass legislation that seeks to reduce juvenile detention utilization through prevention, treatment and rehabilitation services.
- Expanded the controlled substances schedule to include a ban of new formulas of synthetic drugs.
- Secured increased funding for homelessness • programs.

Federal Legislative Successes

In its third year, FAC's federal initiative continued to succeed in efforts to increase water funding and mitigate flood insurance hikes. Over the course of the year FAC, coordinated more than 70 meetings with Congressional members and staff and held weekly conference calls with Florida Delegation Offices.

- Water Participated in the statewide county lobbying effort to secure the passage of the 2013 Water Resources Development Act (WRDA), which authorized more than \$2 billion in water projects Florida – more than any other state.
- Flood Insurance Coordinated the statewide lobbying effort to mitigate the impacts of the 2012 National Flood Insurance Reform Act (a.k.a., Biggert-Waters-12)


- Coordinated with several organizations and entities to develop a consensus strategy for flood insurance reform, including NACo, Florida Division of Emergency Management, Executive Office of the Governor, Florida Association of Realtors, and Greater New Orleans Chamber.
- Provided members with analyses and comparison of over 14 flood insurance bills in the U.S. House and Senate.

WHAT WILL HAPPEN:

FAC is gearing up for another legislative session under leadership focusing on the following member adopted priorities for the 2015 Session:


- Juvenile Justice: Support state funding for the secure detention of juveniles as upheld by Florida's courts and support counties paying actual costs or monthly basis.
- Medicaid: Support state funding for counties that experience disproportionate growth in costs as a res of transitioning to an enrollment based billing syste
- Protecting Florida's Waters: Support sustained commitment of state resources for the development alternative water supplies, water quality improvement and comprehensive water infrastructure needs. Support legislation that enhances regional and loca financial capacity to address water supply developn and water infrastructure.
- Reauthorization of Enterprise Zones: Support • legislation that increases state approved enterprise zone incentives to encourage economic growth an investment in distressed areas.
- Increasing Film and Entertainment Incentives: Seek long-term funding for film, television and entertainment incentives that foster economic development and creates jobs.

WHAT HAPPENED

- NACo Led a coordinated effort with Leon County staff to run the election for Bryan Desloge for NACo 2nd Vice President including budgets, fundraising, campaign calls, travel schedules, volunteer schedules, and design/print campaign materials. Over the year we held weekly campaign meetings and raised funds to support President Desloge's candidacy without sacrificing corporate partners and FAC sponsorships. The campaign involved a team effort of FAC staff, Leon County, commissioners, other county staff and colleagues from across the country supporting Commissioner Desloge's candidacy.
- Strategic Plan Spent the last year developing the • next FAC Strategic Plan. The foundation of the plan was developed by receiving input from FAC staff and the FAC Board of Directors. Over the course of four months, eight regional planning meetings were held to receive additional input from FAC membership. The strategic planning committee then met and discussed the details of the plan and synergized the various comments from across the membership. The plan was adopted in November by the FAC Board of Directors and General Membership and implementation will begin in 2015.
- Ongoing Communication Success In addition . to focusing on the above special projects, our communications department continued their annual success with the publications of News Clips, News

& Notes, the 2014 Calendar, and Annual report. In addition, the website continued to grow with the transition to an updated content management system. The team also visited more 14 papers during our annual editorial board visits and earned media during our ongoing challenge regarding juvenile detention cost share.

Letter from the **Executive Director**

With the quidance of the membership we have developed the strategic plan that shapes the goals of the Association for the next five years. Increasing and diversifying our business opportunities so we can provide access to competitive products and services is a top priority for the Association.

FAC had a unique opportunity to support a campaign on a national level when Commissioner Bryan Desloge became a candidate for the National Association of Counties Executive Committee 2nd Vice President. We collaborated with Leon County Commissioners and staff to organize the ultimately victorious campaign and many of our commissioners from around the state rallied for Commissioner Desloge at NACo events throughout the country. Commissioner Desloge's place on the NACo Executive Committee is a place for all of Florida in the national arena and puts us in a great position as we continue to expand our federal presence.

This year we had unmitigated success during the legislative session. We were able to secure funding for water projects and springs restoration and had a big success in expanding collection of E 911 fees to cover pre-paid wireless phones. We stopped multiple pre-emptions and unfunded mandates and enhanced community public safety by fighting synthetic drugs. Throughout the summer, our Legislative Director Lisa Hurley has continued to fight the burdensome juvenile detention cost share billing system and we will continue to focus on creating a fair system for our counties in the upcoming year.



2014 has also been a successful year for our Enterprise programs. We gained a new Platinum Partner with FMBC and our long time partners Jones Edmunds also became a Platinum Partner this year. We've also expanded our role to provide greater support to our affiliate organizations that will be a beneficial partnership for both organizations.

We will continue to promote the cost saving services offered by our Enterprise partners and look for new services we can offer counties to save time and money. In the coming year we will look to offer new insurance and risk management options for our counties.

Our Education Programs continue to evolve to meet the needs of our Commissioners. More than 60 Commissioners graduated from the Certified County Commissioner and Advanced County Commissioner program at Annual Conference this year. We began offering more opportunities to meet the legislatively mandated ethics requirement in 2013 and to date more than 175 of the County Commissioners and Constitutional Officers have been completed their annual ethics requirements through our program.

When I was hired as the Executive Director of FAC 10 years ago, we were in a much different place then we are now. I am proud of the growth I've witnessed in my time here and have come to think of my staff and the membership as family and it will be hard to leave. However a commitment to growth and change must start at the top and I feel like it is time for some one new to take over the leadership of this organization and I look forward to ensuring a smooth transition. There are many changes in store for the association and I am confident that I am leaving you in good hands.
