#### **Confirmed Cases in Florida**

#### FDOH Launches New COVID-19 Case Dashboard

Today, the Florida Department of Health announced the launch of a new <u>COVID-19 Case Dashboard</u>. To keep Florida residents and visitors safe, informed and aware about the status of the virus, this dashboard will be updated twice daily.

As of noon, there are 155 total\*\* Florida cases:

- This includes 19 additional positive COVID-19 cases (14 Florida residents and 5 non-Florida residents) were reported to the Florida Department of Health.
- There are currently 137 positive cases in Florida Residents and 18 positive cases in non-Florida residents.

#### Actions Taken by the State of Florida

Yesterday, the Governor provided several additional updates on Florida's efforts to respond to COVID-19:

- Governor DeSantis requested that Health and Human Services send home the 61 Floridians that
  were previously aboard the Grand Princess Cruise line, home from isolation from Dobbins Air
  Reserve Base, Georgia.
- Governor DeSantis directed the Department of Health to hire additional epidemiologists from university health programs to help with workload.
- Governor DeSantis directed the Agency for Health Care Administration (AHCA) to extend all
  existing nursing home and assisted living facility licenses for 90 days to remove distraction from
  patient care.
- Governor DeSantis directed Director Moskowitz to expand his emergency order and prohibit all visitation to nursing homes, assisted living facilities, adult family-care homes, long-term care facilities and adult group homes to all visitors for the next 30 days.
- Governor DeSantis directed the Department of Highway Safety and Motor Vehicles to suspend drivers' license renewal requirements for 30 days.
- Governor DeSantis directed all agencies to suspend for 30 days licensing and registration renewal requirements for existing processional licenses (e.g. realtors).
