


FAC Unveils NEW COVID-19 Dashboard



As counties grapple with responding to the ever changing information coming out regarding COVID-19, FAC felt we could all learn from each other. As a result, we began regularly sending out surveys on county's initiatives and now have transitioned to displaying those results in real-time on the COVID-19 County Response Dashboard.

Not only does this dashboard display the real-time results of FAC's previous surveys, it also contains links to the Governor's Executive Order, every county's COVID-19 website, FAC's newsletter updates, the latest state and federal department updates, other helpful external resources like information from DOH and the CDC as well as a constantly expanding list of county's policies and ordinances regarding COVID-19.

In addition to the responses being displayed in real-time, a spreadsheet containing the county-by-county answers to these questions will be updated daily at noon and available for download on the COVID-19 County Response Dashboard. Click here to view the most recent county-by-county information.


