

**HILLSBOROUGH COUNTY ADMINISTRATOR ORDER ESTABLISHING COVID-19  
LIMITATIONS ON HOUR AND ON-PREMISE CONSUMPTION OF FOOD AND  
BEVERAGES IN RESTURANTS, BARS, PRIVATE CLUBS AND OTHER  
ESTABLISHMENTS**

**WHEREAS**, Declarations of Emergency to institute measures to prevent the spread of COVID-19 have been issued by the President of the United States, the Governor of the State of Florida, and the Hillsborough County emergency Policy Group.

**WHEREAS**, Public Health experts have consistently recommended avoiding close physical interaction between people in order to slow the spread of COVID-19, and on March 15, 2020, the U. S. Centers for Disease Control amended their social distancing guidelines to suggest limiting any in-person gatherings to 50 people or less; and

**WHEREAS**, In light of the rapidly-evolving nature of the spread of COVID-19, particularly the imminent threat posed by close social interaction, and pursuant to the authority vested by Florida Statutes, Hillsborough County Code of Ordinances and Laws, by Executive Order of the Hillsborough County Emergency Policy Group, the following Hillsborough County Administrator Order is being issued; and

**WHEREAS**, Section 252.38, Florida Statutes, authorizes Hillsborough County to declare a state of local emergency, and further authorizes Hillsborough County to take whatever prudent action is necessary to ensure the health, safety, and welfare of the community; and

**WHEREAS**, Chapter 22, Article 2, Section 22-22, Hillsborough County Code of Ordinances and Laws (Hillsborough County Emergency Management Ordinance), and the Hillsborough County Comprehensive Emergency Management Plan delegates authority to declare a state of local emergency to the Hillsborough County Emergency Policy Group; and

**WHEREAS**, Section 22-22, of the Hillsborough County Code, specifically authorizes the Emergency Policy Group with the power to declare that a state of emergency exists; and

**WHEREAS**, on March 12, 2020, the Hillsborough County Emergency Policy Group declared a state of local emergency in response to a County wide threat from the COVID-19 Virus for all of Hillsborough County; and

**WHEREAS**, the Hillsborough County Emergency Policy Group delegated to the County Administrator, the emergency management powers of the Emergency Policy Group, as set out in Section 22-23 of the Hillsborough County Emergency Management Ordinance, not already implemented by this Order, are hereby delegated to the County Administrator.

**NOW THEREFORE, UNDER THE AUTHORITY** of the Executive Order of the Hillsborough County Emergency Policy Group, I, Michael Merrill, Hillsborough County Administrator do hereby order:

- **All restaurants, bars, private clubs or other establishments that offer food or drink for sale for on-premises consumption shall close for business daily at or before 10:00 PM.**
- **Any restaurant, bar, private club or other establishment that offers food or drink for sale shall limit their occupancy load by 50% for the on-premises consumption of food or drink during all hours of operation. Such establishments may continue to offer food and non-alcoholic beverages for take-out and by delivery, subject to adherence to all sanitation and social distancing protocols for COVID-19 as set forth in Centers for Disease Control and Florida Department of Health guidance.**

Hillsborough County recognizes that the businesses and employees that will be impacted by this directive are integral to Hillsborough County, and has been working to identify State and Federal programs designed to assist with business loss resulting from this state of emergency.

Hillsborough County, State and Federal Agencies, will continue to monitor this fluid situation and may impose further restrictions as necessary, including the closure of establishments, except for take-out and delivery of food and non-alcoholic beverages.

Hillsborough County encourages all local businesses to refer to the latest information by visiting the [HCFLGov.net/StaySafe](http://HCFLGov.net/StaySafe) and sign up for the HCFL Alert system. Additionally, the Centers for Disease Control has up-to-date information available, as does the Florida Department of Health.

Said Order, as set out above, is to commence at 12:00 PM, March 17, 2020. Any violation of this Order shall be subject to the penalties in Chapter 22, Article 2, Section 22-28 of the Hillsborough County Code of Ordinances and Laws (Hillsborough County Emergency Management Ordinance).
