MAXIMIZING FUNDING TO RECOVER QUICKER AND STRONGER FROM COVID-19

Local governments have a unique responsibility for the safety and well-being of their communities. REIMBURSEMENT GUIDANCE

- Follow both your local and Federal procurement and contracting rules and regulations. If there are differences between the two sets of rules, follow the more restrictive procedures. Non-compliance is the #1 reason for denial and/or claw-back of funding eligibility.
- Document all expenses for the staff, equipment and materials you use for response or emergency protective measures. Remember to establish links between equipment utilization time and the operators assigned to the equipment; also include location so hours are assigned to the appropriate project worksheet.
- Purchase of equipment and supplies such as Personal Protective Equipment is eligible but will require documentation of the function or personnel it was purchased to support.
- Services must be directly related to, not just because of the emergency. This is an important nuance that trips up many applicants seeking federal reimbursement.

CITY OF SAN JOSE, CA COVID-19 AND 2017 FLOOD SUPPORT
