8	WHEREAS, Lake County is currently under a State of Emergency pursuant to Executive Order No. 20-
9	51, as declared by Governor DeSantis on March 1, 2020; and
10	WHEREAS, Resolution 2020-29, dated March 16, 2020, of the Board of County Commissioners of Lake
11	County, Florida, declared a local state of emergency in response to the Coronavirus Disease 2019 ("COVID-19");
12	and
13	WHEREAS, the local state of emergency was extended for an additional seven (7) days via Resolution
14	No. 2020-30, signed on March 23, 2020, Resolution No. 2020-31, signed on March 30, 2020, Resolution No. 2020-
15	47, signed on April 6, 2020, Resolution No. 2020-48, signed on April 13, 2020, Resolution 2020-49, signed on
16	April 20, 2020, Resolution 2020-50, signed on April 27, 2020, Resolution 2020-52, signed on May 4, 2020; and
17	Resolution 2020-53, signed on May 11, 2020; and
18	WHEREAS, COVID-19 has caused and continues to cause a significant public health emergency; and
19	WHEREAS, the Chairman of the Board of County Commissioners of Lake County, Florida, has
20	determined that a local state of emergency continues to exist and hereby declares an extension of the Declaration of
21	Local State of Emergency due to the significant impacts to public health and safety related to COVID-19.
22	NOW THEREFORE, BE IT RESOLVED by the Chairman of the Board of County Commissioners of
23	Lake County, Florida, that:
24	Section 1. Extended Emergency Declaration. An extension to the Declaration and Resolution of
25	Local Emergency is hereby declared for an additional seven (7) days.
26	Section 2. Effective Date; Duration. This Resolution shall take effect upon signature and shall be
27	in effect for seven (7) days or until canceled or extended as required by law.
