## EMERGENCY ORDER 2020-32 THIRTEENTH EXTENSION OF STATE OF GENERAL EMERGENCY IN ALACHUA COUNTY AND IMPLEMENTATION OF PLAN TO OPEN UP AMERICA

WHEREAS, Governor Ron DeSantis has issued Executive Order 20-51 declaring a public health emergency as the result of the spread of the COVID-19 virus; and,

WHEREAS, as the virus spread Governor DeSantis issued Executive Order 20-52 declaring a general state of emergency in all the counties of the State; and,

WHEREAS, President Donald Trump has declared a National State of Emergency due to the COVID-19 virus; and,

WHEREAS, the Governor and the Department of Health have issued several Orders and Directives regarding public safety and limiting public activities to limit the spread of the COVID-19 virus and these directives remain in force; and

WHEREAS, the number of suspected and diagnosed cases in the State of Florida and specifically Alachua County continue to climb; and,

WHEREAS, on April 16<sup>th</sup> President Trump released the Plan for Opening Up America Again which establishes a phased approach to returning to a normal situation; and

WHEREAS, Governor DeSantis has issued Executive Order 20-112 which begins the phased reopening of Florida and has extended the state of emergency in Executive Order 20-114; and

WHEREAS, Governor DeSantis, expanded the phased reopening of Florida in Executive Order 201-123; and

WHEREAS, a Proclamation Declaring a State of Emergency in Alachua County was issued on March 16<sup>th</sup> beginning at 1:04 p.m. which has been extended multiple times most recently in Order 2020-31; and,

WHEREAS, Governor DeSantis has now issued Executive Order 20-139 implementing "Phase

2 Recovery" but has not yet lifted the statewide state of emergency; and,

WHEREAS, Alachua County Emergency Order 2020-30, implements the provisions of

Executive Order 20-139 with local modifications; and

WHEREAS, the Chair of the Board of County Commission is the Official Authority as prescribed

in the County's Code §27.07.

NOW THEREFORE, pursuant to Alachua County Code Section §27.07, the Chair of the Board of

County Commissioners sitting as the Official Authority hereby resolves, finds, and declares:

1. The above recitals are true.

2. The State of Emergency proclaimed on March 16th shall continue uninterrupted for 7 days

beginning at June 22nd at 1:04 p.m.

3. I intend to extend this order by one or more subsequent orders, through a date not earlier than

June 29th, 2020.

4. All other provisions of the proclamation and orders entered pursuant to the proclamation and

state of emergency shall remain in force until lifted or repealed.

5. In accordance with §252.46(2) this order shall take effect immediately upon filing with the Clerk

of Courts for Alachua County.
