What to Consider When Selecting a Provider

Many providers offer a free version of their platform, although there are often limitations on platform usage. Upgrading your subscription usually means you can do more.	Counties should ensure that the video- conferencing tools that they select feature robust security controls, compliance with internal IT security policies, and consider meeting passwords, encrypted sessions and robust administrative controls that allow hosts to permit, deny and eject meeting participants where necessary.	Any video-conferencing platform should have the capability to support the size of your workforce. If you anticipate needing more than 200 people involved in meetings – particularly if you are a medium-sized or larger county – you may want to look for a plan that allows for this.	Beyond video calling and chat, if you plan on using software to screenshare, collaborate on documents and projects as a team, then you will want a platform that facilitates this.	Many video-conferencing tools allow you to record meetings and store them in the cloud (though storage can vary depending by service), while others also provide live captioning and transcription tools to make note taking even easier. This ensures the statutory requirements for counties are maintained.
