Letter to all Lake County Congregate Facilities

## RE: Resolution 2020-133 requiring facial masks for all persons entering any residential or long-term care facility

To help ensure the health and safety of all persons entering or residing in residential or long-term care facilities within Lake County, I have signed Resolution 2020-133 (attached), requiring facial mask coverings for all staff and anyone entering one of these facilities. This local emergency order will assist in providing an additional layer of protection and may help reduce the spread of the Coronavirus Disease 2019 (COVID-19).

This order applies to long-term care facilities regulated by the Agency for Health Care Administration (AHCA), and all group homes regardless of whether they are regulated by ACHA, the Agency for Persons with Disabilities (APD), or the Florida Department of Children and Families (DCF). However, this order does not apply to residents of such facilities who are not required to wear facial masks within their group home settings unless the agency regulating the facility requires them to wear masks, or the facility itself (per its rules or under specific circumstances) requires its residents to wear them.

My goal for this order is to provide education and information to the staff of residential and long-term care facilities to improve the safety practices to protect our most vulnerable population. | 31                    | Section 1. Facial Masks Required in all Residential or Long-Term Care Facilities. All staff and   |  |  |  |  |
| 32                    | anyone entering a residential or long-term care facility must wear a facial mask while in the facility. This order  |  |  |  |  |
| 33                    | applies to all group homes regardless of whether they are regulated by the DCF, APD or ACHA; provided, however,   |  |  |  |  |
| 34                    | that residents of such facilities are not required to wear facial masks within their group home settings unless the   |  |  |  |  |
| 35                    | respective state agency overseeing the facility so requires.  |  |  |  |  |
| 36                    | Section 2. Penalties. Facilities and individuals that do not comply with this Order on a consistent   |  |  |  |  |
| 37                    | basis are subject to monetary fines up to \$500 per occurrence, in accordance with Section 125.69, Florida Statutes,  |  |  |  |  |
