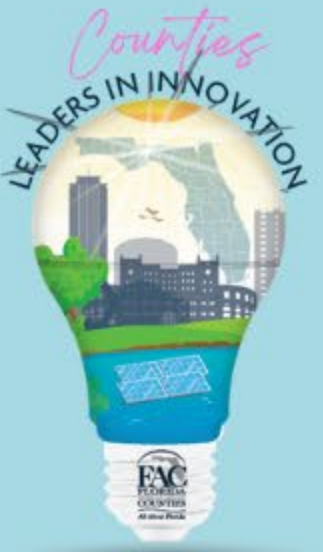

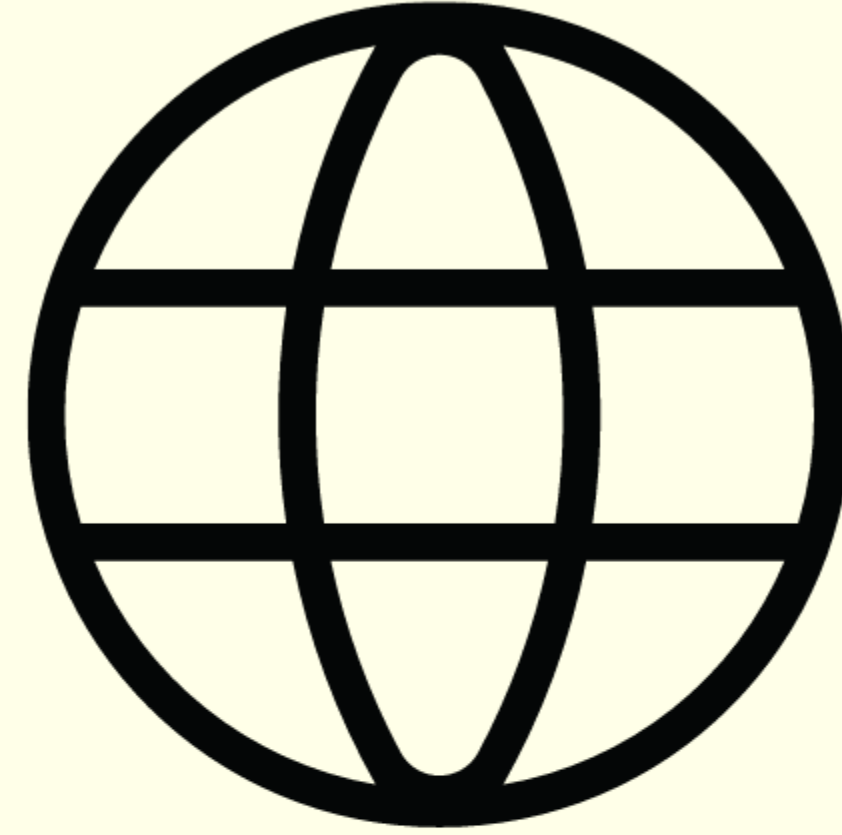

CUA Guiding Principles

Modification to CUA 7 from CUA-PP-04, CUA-PP-05, and CUA-PP-06

- The Florida Association of Counties supports retaining the full amount of dedicated documentary tax revenue to fund state and local affordable housing programs. The Florida Association of Counties further supports increased flexibility to counties participating in the State Housing Initiative Partnership program to maximize the distribution of funds in a manner that more effectively implements each county's local housing assistance plan, adopted local housing incentive strategies, housing-related priorities, and funding for housing projects; and also achieves greater housing availability and affordability for essential service personnel, very low-income, low-income and moderate-income residents, and residents with special housing needs consistent with each county's housing market.
