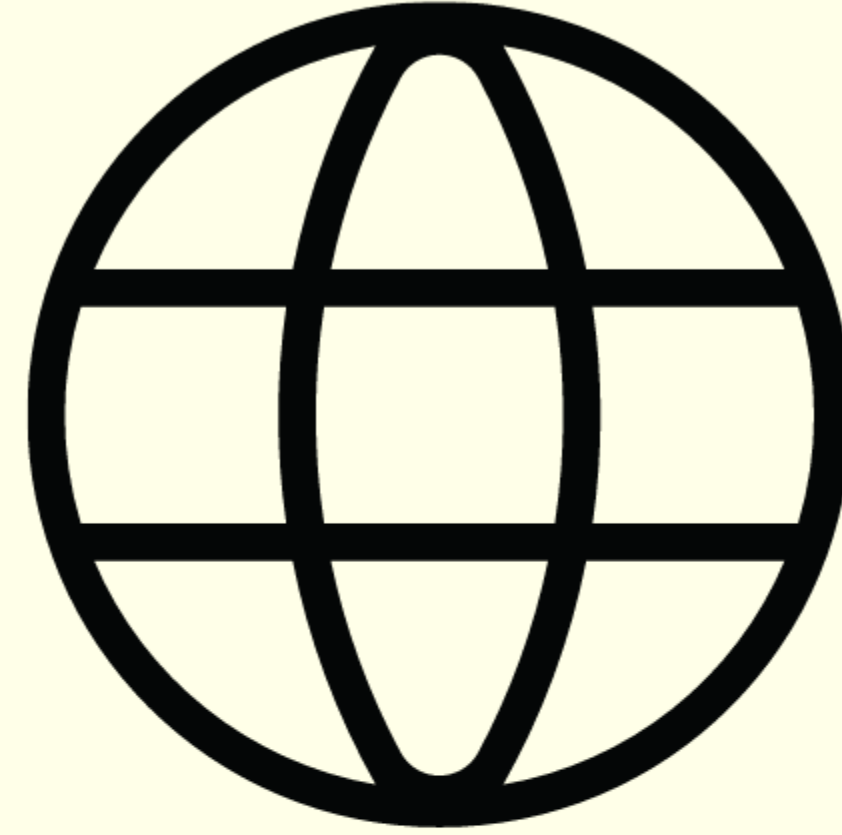

# FTA Guiding Principles

## Modification to FTA 2 from FTA-PP-08

- The Florida Association of Counties supports policies that consider impacts to state revenues shared with counties for the provision of local services and is opposed to permanent modifications to state shared revenue sources or related funding formulas that would significantly impact the counties' ability to continue to fund local services. The Florida Association of Counties supports full formula funding for state shared revenue while opposing any changes to revenue sharing programs that make any county worse off.
