INTRODUCTION



The Florida Association of Counties helps Florida's counties effectively serve and represent their communities through Advocacy, Collaboration, and Education.



MEMBERSHIP

The 67 county members are represented within the Association by their county commissioners, totaling 377 statewide. The Association's constituency also includes appointed county officials, such as administrators/ managers, attorneys and other professional county governmental personnel.



GOVERNANCE

FAC is governed by a Board of Directors composed of one county commissioner from each state senate district (40); five executive officers; six county commissioners appointed at-large with no more than three of the six from counties with population of 75,000 or more; and past presidents of FAC. In addition, the chairpersons or designees of the Institute for County Government (ICG), Florida Association of Counties Trust (FACT), Florida Local Government Investment Trust (FLGIT), and Florida Local Government Finance Commission (FLGFC), if county commissioners, are full voting members of the Board of Directors. The executive officers of FAC are the President, President-Elect, First Vice President, Second Vice President and Immediate Past President. The Executive Committee conducts the business of the Association between Board meetings and recommends the hiring of an Executive Director for approval by the Board of Directors. The Executive Director conducts the daily business of the Association and hires the members of the FAC staff.

OFFICERS AND DIRECTORS BOARD MEMBER RESPONSIBILITIES

What are the responsibilities of the Board?

The major duties of FAC Board members are found in Article VI of the Articles of Incorporation and Article IV of the FAC Bylaws. The Board determines the direction of the programs and policies in accordance with the stated purpose of the Association. In addition, the Board is called upon to:

- Conduct the business of the Association.
- Approve the annual budget and fiscal policies.
- Assist in the development of and approve the legislative policy platform of the Association to the benefit of member counties.
- Actively participate in advocating at the state and federal levels in support of the Association's policy positions.
- Designate standing and study committees and determine their authority, direction and limitations.
- Be an advocate for the Association.

How much time is required by Board Members?

There are three regularly scheduled Board meetings during the 2022-23 year:

September – FAC Innovation & Policy Conference September 14-15, 2022 – JW Marriott Miami, Miami-Dade County

The Board approves the FAC Budget for the upcoming fiscal year and the legislative policy committees meet to begin work on the legislative platform for the upcoming legislative session. There is also a Board exclusive extended meeting and event on evening of Thursday, September 15th.

November – FAC Legislative Conference

November 30 – December 2, 2022 – Hilton St. Petersburg Bayfront, Pinellas County

The Board will meet during this conference and will be provided updates from each department within the Association. In addition, other business decisions will be made by the Board.

June – FAC Annual Conference

June 27-30, 2022 – Hilton Bonnet Creek, Orange County

During this major Association conference the post session legislative report is given and the FAC audit is presented for Board approval.

The 2023 FAC Legislative Day

will be held in March 2023, near the beginning of the 60-day legislative session. While there is not usually a Board meeting at this event, it is an excellent opportunity to meet with legislators as advocates on local government issues. There may be specially called meetings at other times during the year.

Mark Logan has a career spanning over thirty years of public and private sector practice in Florida as

well as Washington, D.C. Mark brings creative problem solving skills and strategic guidance to the firm's clients in the fields of public policy advocacy, administrative and circuit court litigation, business transactions, employment agreements, internal investigations, special districts, compliance, procurement and insurance matters. He practices in all state courts and administrative tribunals, including the Division of Administrative Hearings (DOAH), as well as before the Florida's executive branch agencies and water management districts.

Mark served for several years as the chief legal in-house counsel for a Florida-based data analytics company where his practice focused on contract negotiations, mergers and acquisitions, regulatory compliance and federal and state contracting. He was also a founding partner of a premier lobbying and law firm in Tallahassee where he lobbied both the executive and legislative branches of government as well as represented clients on administrative matters.

In Washington, D.C. Mark worked as Counsel to the United Stated Senate Budget Committee where he was the principal liaison for then Chairman Lawton Chiles and the Senate on procedural elements pertaining to consideration of the federal budget. Mark also was an associate in a large D.C.-based firm focusing on environmental matters, principally for large federal trade association clients. Throughout his career, Mark has been active in Florida politics and political campaigns. He has served as the Florida Director for a Presidential Campaign and as Treasurer to both a Congressional and Gubernatorial campaign where he provided compliance and strategic counsel. Mark has an "AV" Rating from Martindale-Hubbell, is admitted into all Florida State Courts (1985) and the United States District Court for the Northern District of Florida. He received his J.D. from the University of Florida, College of Law (1984) and his B.B.A. from Emory University (1981).

The Legislative Counsel advocates county issues at the state and federal levels through direct participation in litigation and through the researching, drafting and filing of amicus curiae ("friend of the court") briefs in the appellate courts. FAC provides constitutional, statutory and case law analysis on a wide variety of legislative issues throughout the year. In addition, FAC works with the executive branch of the state and federal government in advocating the counties' position on a variety of issues. Finally, FAC participates in the education and training of county commissioners and their staffs throughout the state.

Edward G. "Eddy" Labrador is the Sr. FAC Legislative Counsel. Mr. Labrador is a 32-year member, in good standing, of The Florida

Bar and board certified in City, County and Local Government Law since 1999. He presently serves as Senior Legislative Counsel for the Florida Association of Counties (FAC) which represents Florida's 67 counties before all branches of the U.S. and Florida governments.

Prior to joining FAC, Labrador worked for Broward County, FL., where he held various positions during his 26-year career including Director of Broward County's Office of Intergovernmental Affairs and Professional Standards (OIAPS), a 20-employee, \$3.0 Million county operation, to which he was appointed by County Administrator Bertha Henry. During his tenure as OIAPS Director, Labrador provided executive direction and leadership regarding several key county programs, including federal, state, and local governmental relations; grants; ADA and HIPAA compliance; EEO, Whistle-Blower, Employee Ethics, Living Wage, Wage Recovery, and Cone of Silence compliance, investigations, and enforcement; and enforcement of the County's Human Rights Act.

Labrador also served as Legislative Counsel for OIAPS and its predecessor, the Office of Public and Governmental Relations (January 1, 2007-April 22, 2012). From March 2005 through December 2006, Labrador served as Director of the County's Civil Rights Division. He also served as an Assistant County Attorney for more than 10 years in the Office of the County Attorney, handling a variety of legal areas, including intergovernmental affairs, labor and employment litigation, small business development, civil rights issues, and ethics and elections. From 2001-2005, Labrador represented the Broward County Canvassing Board on elections matters.

Prior to his career with Broward County, Labrador also served as staff counsel for the Florida House of Representatives' Committee on Insurance, focusing on health and life insurance issues. Additionally, he served as a senior attorney/assistant general counsel for the Florida Agency for Health Care Administration (including its predecessor the state DHRS' Office of Regulation and Health Facilities) handling trial and appellate litigation involving certificate-of-need, licensure, health care cost containment matters, bankruptcy issues, and health care facility construction.

Labrador received a Bachelor of Science degree in criminal justice from Florida International University in 1984, and his Juris Doctor in 1989 from Cumberland School of Law of Samford University in Birmingham, AL. In 2016, he was elected President of the National Association of County Intergovernmental Relations Officials (NACIRO), for a two-year term, and served as a member of the National Association of Counties' (NACo) Board of Directors. He is a member of NACo's Transportation Steering Committee and Immigration Reform Task Force; and a former two-term President of the Florida Association for Intergovernmental Relations (FAIR), a professional trade association for city, county and special district representatives engaged in intergovernmental affairs.

He is a member of Hispanic National Bar Association (Advocacy Committee and Special Committee on Cuba), the American Bar Association, International Municipal Lawyers Association (IMLA), the Broward County Bar Association, Broward County Hispanic Bar Association, NACIRO, FAIR, and the Florida Association of Professional Lobbyists. He presently serves as Chair of the Legislation Committee of The Florida Bar's City, County and Local Government Law Section.

Eddy was born in La Habana, Cuba, and has been a citizen of the United States of America since 1975. He resides in Pembroke Pines, FL, with his wife, Emma, a kindergarten teacher at Sunset Lakes Elementary in Miramar, FL, and their two children, Areana and Mikael.



PUBLIC **POLICY** AS OF SEPTEMBER 23, 2021

The Florida Association of Counties has a deliberative, consensus-built policy development process. The goal is to solicit and develop policy statements on legislative issues affecting county government. Through participation in legislative policy committees and caucuses, county officials identify, discuss, and ultimately vote on issues to be in FAC's Legislative Program. Each policy committee and caucus has one presidentiallyappointed Chair and Vice Chair as well as a number of volunteer Policy Leaders. The FAC annual Legislative Program is comprised of two parts: Guiding Principles (which are effective from year to year, unless modified at the Closing Session of the Legislative Conference) and Policy Positions (which are effective for one year, from Closing Session the Legislative Conference to the next).

- Presidential Select Committee on Preemption*

FAC Legislative Caucuses:

- Urban
- Rural

Policy Committee Roles and Responsibilities

- FAC policy committees are referred to as "committees of the whole," meaning that any FAC member county commissioner can volunteer (no later than May 15 of any year) to serve on any and all policy committees and that committee participation is open to any interested county commissioner who is in attendance at the policy committee meetings that take place during conferences.
- Any volunteers seeking to serve as a Policy Leader after August 1 of any given year, must notify the Chair and Vice Chair of the desired appointment. The Chair and Vice Chair of that committee will then

petition the President for acceptance or denial of that request. Only Policy Leaders, the Chair, and Vice Chair have voting privileges in their respective committees. Newly elected commissioners may volunteer by December 31 of the year in which they are elected. The President will appoint these persons to their committees of choice. County staff persons and non-committee members are strongly encouraged to participate in the discussion and provide input but are not permitted to vote.

- Each policy committee includes one presidentially appointed Chair and Vice Chair, and several presidentially appointed Policy Leaders. These roles collectively serve as the Committee Leadership for the respective policy committees.
- Each policy committee has one FAC staff point person, who coordinates Committee Leadership calls, policy committee meetings, and provides education on issues within the committee's purview.
- The Committee Leadership of each committee will have at least one meeting via conference call prior to the Innovation & Policy Conference to discuss the policy development process and Committee Leadership expectations during that conference.
- During the Innovation & Policy Conference, the Committee Leadership, led by the committee Chair and/or Vice Chair and with support from FAC staff, will consider and make recommendations on each policy proposal submitted for consideration. The county submitting the proposal will be responsible for presenting the issue to the committee. Each county submitted proposal must indicate whether the submitting county's BoCC supports the proposal or that that proposal has regional authority support. FAC staff will present FAC-submitted proposals.

Procedures for Legislative Policy Development

- Policies: Single-purpose statements addressing a specific issue or piece of legislation. Policies must address an issue of statewide, regional, or significant and widespread impact and cannot promote individual county or project appropriations. Individual counties or commissioners, or FAC staff may submit Policy Proposals.
- Guiding Principles: General policy principles of statewide importance that are relevant over several years at a time and over several individual policy issues. These statements exist automatically from year to year unless they are modified at the Legislative Conference's Closing Session by the membership.
- Policy Proposals: Proposed policies can be submitted by completing the Policy Proposal Submission Form, which is due 30 days prior to the first Legislative Executive Committee meeting of either the Innovation & Policy Conference or the Legislative Conference, whichever is sooner. Emergency submissions will be considered only upon action by the majority of the Legislative Executive Committee. Emergency submissions are those submitted after the 30 day deadline that address regulatory or legislative matters that could not have been foreseen 30 days before the conference, and are issues of a such timely nature that FAC should consider them immediately. Inaction by the submitter is not such an emergency. FAC will not accept or present for disssion and debate any policy proposals that are not sponsored by a county.
- Vetting of Policy Proposals: Upon submission, FAC staff will vet proposed policies to determine whether they fall within the Policy definition criteria. Proposals that meet the definition criteria will be assigned to a policy committee. During the Innovation & Policy Conference, Committee Leadership of each respective committee will meet to discuss the assigned proposals. At the Innovation & Policy Conference and the Legislative Conference, committees may act on policy proposals in the following ways: accept, defer, or reject. Any proposal may be modified by a committee before final action is taken.

- Voting Procedures: Each policy committee will call the meeting to order and carry out the meeting agenda. In the event that the chair is unavailable, the vice chair will preside over the meeting. Only Policy Leaders, the Chair, and Vice Chair have voting privileges. County staff persons and noncommittee members are strongly encouraged to participate in the discussion and provide input but are not permitted to vote.
- Procedural Rules The latest edition of Robert's Rules of Order as presented to the chair by FAC staff will be used to govern the conduct of committees and caucuses. The Chair of each committee will take each vote to a roll call vote unless the vote is unanimous.

Legislative Executive Committee (LEC)

- The role of Legislative Executive Committee (LEC) is to provide statewide leadership during the policy development process and to approve the policy statements recommended by the respective policy committees at the end of the Legislative Conference.
- The LEC is comprised of the following members: the FAC Executive Committee; the Chairs and Vice Chairs of each policy committee; and the Chairs and Vice Chairs of the Rural and Urban Caucuses and all past presidents of the Association who are still hold office as a county commissioner.
- Policy Leaders are permitted to attend LEC meetings, but they are not permitted to vote.
- The LEC meets twice during both the Innovation & Policy Conference and the Legislative Conference, once prior to committee meetings beginning and once at the conclusion of committee work.
- At least one Chair or Vice Chair of each policy committee and caucus must attend the LEC meeting and provide a brief description of the policy proposals to be discussed at its committee meeting and the outcome of those discussions. During the first LEC meeting of each policy development conference, any policy committee chair (or vice chair if chair is absent) may claim cross jurisdiction of a policy proposal and have it heard in an additional committee. Such a claim will be effective unless

the LEC votes, upon proper motion and by a major of those present, to prohibit such cross jurisdiction.

- Upon completion of the Legislative Conference policy committee work, the LEC will meet, hear reports from each policy committee chair, and act
- on them, in whole or in part. The LEC must vote to recommend FAC's complete legislative policy statements and top priorities for the next legislative session. That recommendation moves to action by the full membership at the Closing Session of the Legislative Conference.
- During the course of the legislative session, the LEC meets weekly via conference call (usually on Friday mornings) and is responsible for any revision, modification, deletion or addition to the policy statements adopted by the membership and may make interim policy decisions as needed.

ASSOCIATION FINANCES

FAC's Financial Information At-a-Glance

Fiscal Year:

November 1 through October 31

Oversight:

Finance & Audit Committee – This standing committee is established under Article X of the FAC Bylaws and is chaired by the FAC President-Elect. The committee meets at least semi-annually and reports to the Executive Committee and Board of Directors.

Budgets:

Budget is approved at the Board of Director's meeting held in conjunction with the Fall Innovation and Policy Conference. The FY2021/22 budget totals \$4.9 million, of which 40% is funded from member dues. The remainder is funded from such member services as conferences, publications, and enterprise programs, as well as other income such as investment and rental income.

Fiscal Goals:

To maintain fiscal stability necessary for the ongoing operations of the Association and to develop the fiscal infrastructure necessary to fund future growth of the organization, as outlined in the FAC Strategic Plan.



FAC policy provides for a goal of 12 months of operating reserves and the funding of capital reserves on an annual basis. In addition, FAC has created additional reserves such as Public Awareness Reserve, Litigation Fund, and Business Development Fund Reserves. The total of all reserves is approximately \$4.9 million as of FYE2021.

Investments:

Investments are guided by the Association's investment policy.

Other Assets/ Commitments:

FAC owns 4 adjacent buildings (approx. 15,000 SQF) in Leon County, Florida which form the headquarters for the Association. Currently, the Association leases approximately 1/5 of the space to outside tenants. The buildings are estimated to be worth approximately \$2.5 million and are owned outright.

Internal Controls:

The Association has implemented various policies over the past twenty years. These policies are reviewed periodically and new policies are instituted as needed.

Reporting:

Internal financial statements are produced monthly and distributed to management staff. Financials are also provided to the Finance & Audit Committee, Executive Committee and Board of Directors on a periodic basis or in conjunction with meetings.

Audit Functions:

The Association is audited annually by an independent auditor and the audit results are reported directly to the Finance & Audit Committee. Since FY 1995/96, the Association has received unqualified/unmodified opinions.

EXTERNAL **AFFAIRS**

The FAC communications department works with each division in the Association to communicate effectively and in conjunction with each other to best represent the Association as a whole. Communications focuses on educating Floridians and providing members the tools needed to effectively communicate the importance of home rule.

Media Relations

Working closely with the capitol press corps and county reporters to build a relationship that is an information exchange and through which FAC is the first expert reporters consider when writing on county issues. Annually FAC visits with editorial boards across the state and educates them on FAC's legislative priorities.

Issue Management

Through strategic initiatives, FAC strives to enhance awareness among key audiences about the role and function of county government and the impact state actions will have on county initiatives. KeepItLocalFlorida.org (KILF) has been developed to be a grassroots partnership with the Florida League of Cities. KILF sends emails to more than 500,000 citizens monthly focusing on home rule issues.

FAC Web and Social Media Presence

Over the past four years the Communications department has worked to extensively increase the Association's web and social media presence as a resource for local governments. The Communications department is responsible for the FAC website, the Institute for County Government website, the FAC Research website and manages four affiliate websites. FAC has also continued to grow its social media engagement through Facebook, Twitter and Instagram. The communications team in conjunction with the each of the Association's departments coordinates and produces timely and relevant content to keep our members informed.

FAC BUSINESS

Debt Recovery (NCS Plus)

This innovative program gives local governments a way to manage their accounts receivable for less than 10% per account, regardless of the amount owed. Under this flat-fee model, all delinquent accounts are worked equally and recovered debt goes back to the county instead of the collection agency. NCS Plus can handle collections for courts, emergency services, utilities, and other community services.

Commercial Paper Loans (Florida Local Government Finance Program)

FLGFP is a flexible, low-interest, short- to medium-term loan program built by counties and designed to help local governments meet their infrastructure and capital needs. Backed by J.P. Morgan Chase Bank, the program helps to fund projects such as landfills, water and sewer facilities, courthouses, spring training complexes, library construction, beach re-nourishment, and more.

Florida Local Government Investment Trust (Florida Trust)

The Short-Term Bond Fund is a member-governed pooled investment program designed to add value over short term alternatives while maintaining safety of principal and liquidity.

The Day to Day Fund is a money market product that provides a fiscally conservative diversification option for local governments. Both funds are professionally managed by Payden & Rygel and AAA by Fitch.

Florida Association of Counties Trust (FACT)

FACT is a pooled risk-sharing program designed to fill the needs of local governments for liability coverage and to provide lower costs, greater stability, more flexibility and broader coverages than are generally available.

Florida Municipal Trust (FMIT)

FAC has partnered with FMIT and the Florida League of Cities to offer bundled coverages including workers' compensation, property, first dollar deductible programs, deductible stop loss plans and self-insured retention options.

Deferred Compensation (Nationwide)

This program provides county employees with a Section 457 Deferred Compensation Program, as well as another tool for retaining quality employees by enhancing a county's employee benefits package at no cost to the county.

Vehicle Cooperative Purchasing Program (Florida Sheriffs Association)

The Cooperative Purchasing Program offers a statewide purchasing contract on a variety of vehicles and equipment which is available to Sheriff's offices, local government agencies, state universities and colleges and State of Florida agencies.

Live Healthy Program (NACo/CVS Caremark)

NACo has partnered with CVS Caremark to offer relief to uninsured and underinsured Americans who face high prescription, health and dental costs. The program is free to NACo member counties and includes discounts on prescriptions, vision care, LASIK & PRK vision procedures, hearing aids & screenings, prepaid lab work, prepaid diagnostic imaging, diabetic supplies and dental care.

INSTITUTE FOR COUNTY GOVERNMENT

MISSION

The mission of the Institute for County Government is to enhance the leadership skills of county officials, to facilitate innovative thinking and action by those leaders, and ultimately to enable counties to prosper as communities in the 21 st century.

In June 2018, the FCF Board of Directors adopted a strategic plan with four specific goal areas:



Education:

Expand educational opportunities for members.



Research:

Become the most trusted resource for Florida county data and information.




Strengthen the current partnership with UF/IFAS and develop new partnerships with organizations that will further the mission of the FCF.



Revenue Diversity:

Grow and diversify revenue streams to support FCF activities

Functionally, each goal area has specific tasks that are used to implement the plan. Tasks are ultimately carried out under distinct programs of the ICG, as shown below.



EDUCATION

Historically, education and training have been the flagship of the ICG, and that trend continues under the new strategic plan. Since 2018, the ICG has developed and delivered five new elective courses, evaluated alternative teaching options (i.e., online training), implemented a new leadership program, and programmed additional elective classes.

COUNTY COMMISSIONER CERTIFICATION (CCC) PROGRAM

To receive certification, commissioners must attend 45 hours of training that generally takes from 6 to 12 months to complete. The core curriculum includes training on county government structure and authority, roles and responsibilities, financial management, growth management and ethics. Elective curriculum consists of topics such as economic development, diversity training, effective communications, Florida's legislative process, land use decisions, negotiating skills, and others.

COUNTY GOVERNMENT EDUCATION PROGRAM (CGE)

Launched in 2017, this program is a voluntary program of study based on our current Certified County Commissioner (CCC) program and designed for county staff. To receive certification, staff must attend 45 hours of training that generally takes from 6 to 121CG months to complete. Content for this program includes county government structure and authority, finance and budget, growth management, ethics and Sunshine Law, and Florida's legislative process and so much more.

CONTINUING EDUCATION ANNUAL CONFERENCE EDUCATION PROGRAMS

The Institute is also responsible for planning FAC's Annual Conference workshops and general sessions. The programs cover a broad range of topics of interest to county officials and are designed to appeal to newly elected and veteran commissioners.

CURRICULUM REVIEW COMMITTEE

Every other year, the ICG Board and a select group of Commissioners and county staff are called together to form the Curriculum Review Committee. This group meets every other year to review the course curriculum, usually a one-day meeting in August.

ICG LEADERSHIP FORUM

Advanced County Commissioner – Level I (ACC) Program

Launched in August 2006 as the Florida Forum for County Leaders, this educational program is designed for County Commissioners who have earned their CCC graduate designation. It is a 3-part series of 1 ½ day seminars focused on leadership with an overarching theme of growth and development in Florida. Those selected must complete all three programs to receive the advanced designation.

Advanced County Commissioner – Level II (ACC) Program

Launched in May 2019 as the Leadership Academy, this educational program is designed for County Commissioners who have earned their ACC Level I graduate designation. It is a 3-part series of 2-day seminars focused on leadership with an emphasis on Florida issues. Attendees must complete all three sessions to graduate from the program.

POLITICAL TRAINING PROGRAM

The FCF Strategic Plan called for the development of a new Political Candidates Training Course for commissioners that are considering running for higher office. ICG has engaged a variety of speakers to bring workshops to Annual Conference for those interested in running for a higher political office since 2018. The workshops have included a panel of former state legislators, who are now county commissioners, as well as former commissioners currently serving in the Legislature.

CHAIRMAN'S PROGRAM

During FAC's 2018 Legislative Conference, the FCF offered its new Chairperson's Training Institute. The program was directed at commissioners who will be serving as Board chairs for the first time. The program offered strategies in meeting decorum, rules of order, working with the public, and other procedures for running effective meetings. The course was taught by Vince Long, Leon County Administrator, and Herb Thiele, former Leon County Attorney. The class was well attended with 21 commissioners participating. Staff has recommended that the program be a standing elective within the education program and it is currently available through the online course catalog.

RESEARCH

Research within ICG is important for developing new and relevant education curricula. This is particularly true as we witness the growth in new and emerging technologies like smart cars, autonomous vehicles, micro mobility transport, and small cell infrastructure. Anticipating how these and other innovations may impact counties is at the core of ICG Research. By monitoring state and national trends in technology and public policy, ICG develops appropriate information and education materials that inform counties and help local decision making.

SIGNATURE INITIATIVES

To increase its exposure, facilitate potential entrepreneurial opportunities, and leverage training prospects, the ICG Board included Strategic Initiatives as a part of its strategic plan. Anticipated and realized initiatives include:

CERTIFIED COUNTY COMMISSIONER EDUCATION PROGRAM

The Certified County Commissioner Program was created in 1996 as a voluntary program of study designed for county commissioners to learn information and enhance skills relevant to their duties and responsibilities. Completion of the course requirements results in the designation of Certified County Commissioner. To date, 538 commissioners have graduated from the CCC program.

REQUIREMENTS FOR CCC DESIGNATION

This program was designed for county commissioners. Only commissioners will receive the Certified County Commissioner designation.

CCC courses were typically offered year-round at FAC conferences until the pandemic of 2020. To accommodate not being able to meet in person, a learning management program was launched allowing members to complete their course requirements online. This program may now be completed within 6-12 months. To graduate, commissioners will need 45 total hours of credit. This includes 30 hours of core, 9 hours of elective and 6 hours of continuing education. The CCC graduation ceremony is held every year during FAC's Annual Conference.

CERTIFIED COUNTY COMMISSIONER PROGRAM TOPICS

CORE CCC COURSES: The program content for each core course is designed to cover fundamental information necessary to effectively serve as a county commissioner. To be certified, commissioners must earn a minimum of 30 credit hours of core curriculum. Each core course is equivalent to 6 hours of credit. These programs are currently offered through the online course catalog.

ADVANCED COUNTY COMMISSIONER EDUCATION PROGRAM

Launched by the Florida Counties Foundation in 2006, the Advanced County Commissioner (ACC) education program, "The Florida Forum for County Leaders", is an advanced leadership program designed for graduates of the Certified County Commissioners (CCC) program. The course is limited each year to 22 CCC graduates and to date, there are 284 graduates of this program.

PREMISE OF THE ADVANCED COUNTY COMMISSIONER – LEVEL I PROGRAM

County officials are uniquely positioned to achieve positive change within their counties and in their relationships with local and state government partners. The task is to prepare for the future by thinking and acting anew and asserting skillful leadership in times of daunting challenges and rapid change.

The future of our communities and the governments that serve them depends upon:

- The caliber of leadership and stewardship public officials provide.
- The degree to which local government officials shape the future through leadership that engages the best in people.
- The willingness and capacity of county government officials to be pacesetters in redefining local government excellence and intergovernmental partnerships.
- The application of thoughtful leadership and strategic planning.
- Recognizing the paramount role county leaders have in effectively convening, involving and working with the critical stakeholders.

REQUIREMENTS FOR ACC – LEVEL I DESIGNATION

The ACC program is organized as a series of three seminars, with 27 hours of course work. The course content focuses on leadership with an overarching theme of growth and development in Florida. Courses are different for each series and cannot be repeated. Participating Commissioners must commit to fully participate in all three seminars in order to graduate.

ACC – LEVEL II – LEGACY LEADERS

In 2019, due to requests for more education, a second Advanced County Commissioner Program debuted as ACC – Level II – The Leadership Academy. This program mirrors the ACC – Level I Program with a series of three seminars and a total of 27 hours of course work. The content is focused on leadership in the state of Florida. Courses vary for each session and are based on current issues affecting state leaders. Commissioners must complete all three sessions to graduate. There are 41 graduates of this program since the first class in 2020.

CERTIFIED COUNTY GOVERNMENT EMPLOYEE PROGRAM

In 2017, the Institute launched the County Government Education Program for county staff, a voluntary program of study designed for county staff to learn information and enhance skills relevant to their duties and responsibilities. Completion of the course requirements results in the County Government Education (CGE) designation.

REQUIREMENTS FOR CGE DESIGNATION

The County Government Education courses were typically offered year-round at FAC conferences until the pandemic of 2020. The Core, Elective and Continuing Education Courses will include all the courses in the CCC program with the exception of the New Commissioner Orientation and New Commissioner Workshop. County staff also have the option to receive elective course credits for participating in other professional workshops with organizations that are affiliated with FAC.

To complete the course work for the County Government Education Program, county staff will take a total of 45 hours of courses. There is no timeline to finish, however the program may be completed within 6 to 12 months now that it is offered online. At FAC's Annual Conference each year in June, we will recognize the staff that have completed the program. To date, there are 30 graduates from this program.

COUNTY GOVERNMENT EDUCATION PROGRAM TOPICS

CORE CGE COURSES: The program content for each core course is designed to cover fundamental information. County staff must earn a minimum of 30 credit hours of core curriculum. Each core course is equivalent to 6 hours of credit. These programs are offered through the online course catalog.
