

Evan Feinman is the director of the Broadband Equity, Access, and Deployment Program, the primary program deploying broadband created by the Bipartisan Infrastructure Law. Evan is responsible for leading NTIA's historic broadband deployment program.

Evan has previously served in multiple roles within government, on political campaigns, and in the private sector; most recently directing both the Virginia broadband effort and a state economic development agency.

WHAT'S NEXT?

LEGISLATIVE OUTLOOK There are more than 80 federal programs across federal agencies have been allocated funding that can be used for broadband-related purposes, including E-Rate (FCC/ USAC), Reconnect (USDA), Community Connect Grant Program, Rural Digital Opportunity Fund (RDOF), and more.

These federal investments, will be coming to the state of Florida for planning, rulemaking and distribution. The Florida Legislature will have a large hand in focusing these funding priorities as well as setting the parameters on spending.
